## Gentlemen:

The purpose of this letter is to revise a corrective action completion date. A reply to NRC Notice of Violation RII-95-12-03-SL4 was provided by letter dated June 19, 1995. A corrective action identified within the reply stated that, "Procedure PM-402 will be revised to include breaker timing testing as part of PM testing. In addition, procedure Preventative Maintenance (PM)-163, "Inspection and Testing of Circuit Breakers for 480 Volt Bus E-2," will also be revised to include breaker timing testing." We committed to full compliance by July 26, 1995.

Implementation of the corrective action in response to this NRC violation requires that our engineering personnel provide the timing requirements based on vendor recommendations. The applicable vendor(s) have been unable to provide the necessary information to support a timely revision to procedures PM-163 and PM-402 in order to meet the committed date. To allow sufficient time for the development and implementation of the timing requirements, the completion date for this action is requested to be extended until September 22, 1995. The revised commitment date will allow engineering to obtain the necessary vendor recommendations for timing requirements and incorporate them into the affected procedures in a reasoned and methodical manner. As an interim measure, breaker timing tests are being performed utilizing a generic method required in procedure Maintenance Management Manual (MMM)-003, "Maintenance Work Requests."
