The investigation was initiated on April 26, 2013 to determine if a senior quality assurance engineer was subjected to discrimination by management at System One Services (System One) and Westinghouse Electric Company (Westinghouse) for raising safety concerns. OI conducted interviews with staff at System One and Westinghouse and reviewed various documents to examine the facts and circumstances of the case. Based upon the evidence developed during the investigation, the NRC did not substantiate the above allegation.
