ADMINISTRATIVE REVISION TO LICENSE AMENDMENT REQUEST
CONCERNING ALARMING DOSIMETERS

Gentlemen:

The purpose of this letter is to request an administrative change to the proposed wording of a previously submitted Technical Specifications (TS) Change Request. Carolina Power & Light (CP&L) Company submitted a request dated November 4, 1993, which would allow the use of electronic devices (i.e., alarming dosimeters) which continuously integrate the radiation dose rate in lieu of survey meters in high radiation areas.

Subsequent discussions with the NRC resulted in the recognition that certain changes to the wording originally proposed are preferable to ensure the approval of the request. Accordingly, we are providing the enclosed proposed Technical Specification page which incorporates the revised wording as a replacement for the page provided in our November 4, 1993, submittal.

This revision does not change the conclusions of the Significant Hazards Consideration Analysis provided in the November 4, 1993, submittal. An affidavit supporting this revision to our proposed TS change is also enclosed.
