H. B. ROBINSON STEAM ELECTRIC PLANT, UNIT NO. 2 DOCKET NO. 50-261/LICENSE NO. DPR-23 REVISIONS TO TECHNICAL SPECIFICATIONS CHANGE REQUEST REGARDING INSTRUMENTATION SYSTEMS

Gentlemen:

On December 10, 1995, we submitted a request for a Technical Specifications (TS) change regarding the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2 TS Section 3.5, "Instrumentation Systems." Subsequent internal review identified that certain revisions are necessary to the December 10, 1995 submittal to more accurately reflect the requirements of the plant's configuration, plant specific terminology, and to provide necessary renumbering of action statements. A copy of the affected pages, marked up to show the changes, are enclosed, as well as retyped TS pages to replace corresponding TS pages in the December 10, 1996, submittal.

Specifically, this letter provides revisions to TS Table 3.5-2, "Reactor Trip Instrumentation Limiting Operating Conditions," notation "*" and TS Table 3.5-2, Action 8 to reflect the plant specific configuration. A new Action 13 is being added to Table 3.5-3, "Engineered Safety Features Instrumentation Limiting Operating Conditions," for item 2.A "Containment Spray-Manual" in recognition that loss of one instrument channel would result in the manual containment spray function becoming inoperable. Subsequent Action statements are renumbered. Also, on TS Table 3.5-3, the designations "P-11" and "P-12" are being deleted since these designations are not used at HBRSEP, Unit No. 2.

These revisions do not change the basis for our safety evaluation, environmental evaluation, or for the basis for the supporting information provided in our December 10, 1995 submittal that the proposed changes do not involve a significant hazards consideration.
