SUBMITTAL OF UPDATED FINAL SAFETY ANALYSIS REPORT REVISION 14

Gentlemen:

In accordance with the requirements of 10 CFR 50.71(e), Carolina Power & Light (CP&L) Company is submitting one original and ten copies of Revision 14 to the Updated Final Safety Analysis Report (UFSAR) for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. In accordance with the regulations, this UFSAR revision is being submitted within six months following the most recent refueling outage, which was completed on October 20, 1996. Accordingly, this revision is due to be submitted by April 21, 1997.

Revision 14 includes, as appropriate, the effects of: changes made to the facility and procedures as described in the UFSAR, safety evaluations performed in support of requested license amendments and in support of conclusions that changes did not involve an unreviewed safety question, and analyses of safety issues for the period between June 21, 1995 and October 20, 1996. These changes have been appropriately located in the UFSAR.

It should be noted that CP&L has in progress an initiative to improve the UFSAR. This initiative was described in a May 30, 1996, presentation to the NRC.

In accordance with 10 CFR 50.54(a)(3), this submittal includes changes to the Quality Assurance Program that do not reduce the level of commitment in the Program.
