SUBJECT: ROBINSON OPERATOR LICENSING AND REQUALIFICATION TRAINING PROGRAMS  
DURING THE EXTENDED STEAM GENERATOR REPLACEMENT OUTAGE

In a telephone conversation on March 6, 1984, between Mr. Charles Bethea, Robinson Training Supervisor, and Mr. Bruce Wilson, Chief, Operator Licensing Section, a future meeting was proposed to discuss the Robinson Operator Licensing and Requalification Programs as they relate to the extended steam generator replacement outage. In particular, the NRC staff is concerned about CP&L's plans to implement the provisions of your requalification program during this outage and to be able to comply with the provisions of 10 CFR 55.31(e) when the plant is returned to operation. Since CP&L has requested two operator licensing examination visits during the planned outage we would also like to discuss your plans for the candidates being able to meet the eligibility requirements as specified in 10 CFR 55 and NUREG-0737.

The Region II staff and representatives of the Licensee Qualification Branch, NRR will be pleased to meet with your staff at a mutually agreeable date to discuss this subject.
