Gentlemen:

Carolina Power & Light Company's (CP&L) license amendment request dated May 7, 1988 transmitted a supporting report by Westinghouse Electric Corporation discussing the small break loss-of-coolant accident analysis (CPL-88-538, dated May 5, 1988). The continuing review by CP&L led to discussions with Westinghouse regarding the correctness of the Figure 15.6.2-10 included therein. It was discovered that due to an administrative error, the wrong plot was included in the report. The correct Figure 15.6.2-10 for the 1.5-inch break is attached. 
