REPORT OF TRACE INVESTIGATION FOR TRANSFER OF LICENSED MATERIAL

Gentlemen:

In accordance with 10CFR20.311(h)(2), Carolina Power and Light Company (CP&L) hereby submits this report concerning a trace investigation of a shipment consisting of dry active contaminated waste.

On April 5, 1990, H. B. Robinson (HBR) shipment SEG-90-01, consisting of two 1,280 cubic foot Sea Land containers of dry active contaminated waste, was shipped to Scientific Ecology Group (SEG) in Oak Ridge, Tennessee for processing. HBR personnel notified SEG on that date of the shipment. On April 6, 1990, SEG was contacted by HBR personnel, and it was verbally confirmed that the shipment had been received and accepted by SEG.

On April 26, 1990, HBR contacted SEG to report that the signed copy of the manifest documentation had not been received, acknowledging SEG receipt of the shipment, as required by 10CFR20.311(f)(1). Upon investigation of the issue, it was discovered that SEG had inadvertently returned the manifest documentation on April 17 to CP&L's Shearon Harris Nuclear Power Plant rather than H. B. Robinson. SEG immediately transmitted to H. B. Robinson a facsimile of the documentation. Upon receipt of the manifest via facsimile on April 26, the investigation was terminated.
