Dear Mr. Varga:

This is in regard to your letter dated May 21, 1980 (received on June 2, 1980), which requested additional information concerning our March 23, 1979 submittal of the Safeguards Contingency Plan for H. B. Robinson Steam Electric Plant, Unit No. 2. Your letter requested the information within 30 days.

Concurrent with this request, Carolina Power & Light Company (CP&L) is (1) updating the Industrial Security Plans for both Robinson and Brunswick Plants in accordance with 10CFR50.54(p) and previous commitments to NRC, and (2) preparing responses to security-related I&E Inspection Reports for both plants. Therefore, if acceptable to the Staff, CP&L plans to submit the requested additional information for the Robinson Safeguards Contingency Plan by August 1, 1980.
