Summary

In accordance with the Code of Federal Regulations, Title 10, Part 50.90 and Part 2.101, Carolina Power & Light Company (CP&L) hereby requests revisions to the Technical Specifications for the H. B. Robinson Steam Electric Plant (HBR) Unit 2. These revisions involve the addition of three safety related hydraulic snubbers to Table 3.13-1 as required by Technical Specification 3.13.1.d.

Details

Three existing hydraulic snubbers, Nos. 28, 29 and 30, installed on the feedwater system piping have been reclassified as safety-related and should be added to Table 3.13-1 of HBR's Technical Specifications. These snubbers have been routinely tested as part of our hydraulic snubber surveillance program.

The affected page is enclosed for your review.

The requested change to the Technical Specifications constitutes one Class II amendment in accordance with 10CFR170.22. Accordingly, our check for \$1,200.00 is enclosed.
