Dear Mr. Serrant:

This refers to your letter dated March 31, 2014 requesting renewal of your license and your letter dated May 14, 2014 requesting a change of your Radiation Safety Officer

As stated in our letter dated January 30, 2014 (enclosed), we informed you that your license would expire on February 28, 2014 and that you must submit an acceptable renewal application at least 30 days prior to the expiration date if you wish to continue to maintain your license beyond its expiration date.

We also reminded you of this deadline during a telephone conversation on February 19, 2014, with Mr. Reinaldo Franco from your office and Steve Courtemanche from our office. You were notified that we had not received a renewal application although your license was about to expire on February 28, 2014. Mr. Courtemanche also informed Mr. Franco that if you did not submit the required renewal application, your license would expire. Any application we received after that time would be considered a new application and require a fee.

We cannot process the requests at this time because your license expired on February 28, 2014, and you did not respond by the required deadline. The correspondence received after that date is being returned to you.

In addition during an NRC inspection conducted on June 5, 2014, we found that you are in possession of radioactive material (contained within an equipment calibration device) without a valid license. You must take immediate action either to transfer the material to a recipient that is licensed and authorized to receive it or provide a new license application using the guidance in NUREG-1556, Volume 2, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Industrial Radiography Licenses." The checklist in Appendix C in NUREG-1556, Volume 2 contains procedures that are acceptable to the NRC and may be used to submit your response.
