REVISED TECHNICAL SPECIFICATION PAGE - CORE OPERATING LIMITS REPORT

Gentlemen:

On January 7, 1991, Carolina Power & Light Company requested a revision to the H. B. Robinson Unit No. 2 (HBR2) Technical Specifications (TS). The proposed amendment implements guidance provided in Generic Letter 88-16, by proposing changes to allow the use of a Core Operating Limits Report. This request is still under staff review.

In the interim, on April 29, 1992, Amendment 140 was issued for the HBR2 TS to change the required refueling shutdown margin. This amendment independently changed a page which is still under staff review for our January 7, 1991 request. Enclosure 1 provides revised TS page 3.10-10, which reflects the change issued with Amendment 140, as well as the proposed changes in our January 7, 1991 submittal, and should be substituted for the corresponding page in our original request.
