SUBJECT: MEETING SUMMARY - NRC INSPECTION REPORT NO. 50-261/87-26

This letter refers to the Enforcement Conference held at our request at the Region II Office on August 21, 1987, to discuss the findings of the inspection conducted by Ms. O. Masnyk at your H. B. Robinson facility on August 13-14, 1987. The inspection findings related to an unlocked protected area door allowing the entry of an unsearched, unbadged licensee employee, and an unbadged, unsearched, unauthorized individual into the protected area. A meeting summary is enclosed.

Our concerns about this incident were expressed to Carolina Power and Light Company representatives at the meeting. The issues discussed at the meeting and addressed in Inspection Report No. 50-261/87-26 dated August 11, 1987, and the enclosure to this letter are under consideration for escalated enforcement action. Accordingly, no Notice of Violation is being issued at this time and no response is required. However, please be advised that the number and characterization of the violations may change as a result of further NRC review.

It is our opinion that this meeting was beneficial and has provided for a better understanding of inspection findings and enforcement issues.

In accordance with 10 CFR 2.790(d) and 10 CFR 73.21, safeguards activities and security measures are exempt from public disclosure; therefore, the enclosure to this letter will not be placed in the NRC Public Document Room.
