Dear Mr. Carlson:

Enclosed is Amendment No. 12 to your NRC Materials License No. 21-26253-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

In letter dated April 19, 2014, you requested that two locations of use be decommissioned and removed from your license. You provided information to support the decommissioning of your locations at 38900 West 10 Mile Road, Suite 300, Farmington Hills, Michigan and 30029 Research Drive, New Hudson, Michigan. You provided additional information to support this in an e-mail to me dated June 18, 2014.

The NRC staff has reviewed all of this information, including your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from these facilities and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required. Your facilities at 38900 West 10 Mile Road, Suite 300, Farmington Hills, Michigan and 30029 Research Drive, New Hudson, Michigan are both suitable for unrestricted use.

In addition, you requested in your letter dated April 19, 2014 to add an authorized user, Matthew G. Buczek, M.S. However, you informed me during our telephone conversation on June 11, 2014, that you no longer wanted to list Mr. Buczek, and you reiterated this in the aforementioned e-mail on June 18, 2014. Therefore, we did not list Mr. Buczek on your license as originally requested.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order

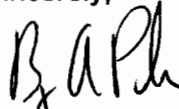
suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Pursuant to NRC's RIS 2005-31 and in accordance with Title 10 of the *Code of Federal Regulations* Section 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
