

On March 11, 1981, CP&L filed a request for exemption from Section III.0, 10CFR50, Appendix R, concerning the reactor coolant pump lube oil collection system. During the ensuing time period, discussions between the NRC staff and industry have led to clarifications of the type of information required for an exemption submittal. Accordingly, we plan to file additional information concerning this exemption request.
