I'm reviewing the action to add you as RSO, add Dr. Phelps for Y-90 use and update the HDR model. I need a couple of things to complete this:

1) The Y-90 guidance indicates:

In addition, the applicant shall commit to provide training in the licensee's procedures to all individuals involved in Y-90 microsphere use, commensurate with the individual's duties to be performed. This training must be provided to all individuals preparing, measuring, performing dosimetry calculations, or administering Y-90 microspheres.

Please provide this commitment.

2) In your June 17 fax re: the HDR unit, it is not clear that you no longer have the Model 105.990. Please briefly clarify the situation with these models.

Dear Mr. Parker,

In my June 17 fax, I requested an amendment to license number 21-08317-01 for Munson Medical Center to remove the old version of the HDR unit.

Model 105.990 was removed from service, returned to the seller, and replaced with Model 106.990. It is no longer in our possession.

In my letter dated May 6, 2014, I requested adding Y-90 microspheres. Please include the following statement:

Munson Medical Center shall commit to provide training in the licensee's procedures to all individuals involved in Y-90 microsphere use, commensurate with the individual's duties to be performed. This training must be provided to all individuals preparing, measuring, performing dosimetry calculations, or administering Y-90 microspheres.
