Information needed to name you as RSO again

SUMMARY

We have a letter dated April 1, 2014, to name you as RSO for this license again. In order for us to do this, we must have your consent to accept the position as RSO and a brief written statement that you understand the duties and responsibilities of serving as the RSO. It is preferred, and not necessary, to include a copy of your last amendment request to us, which was dated September 13, 2013, as was done with the April 1, 2014 letter. We already have that and took final action on it. It has no bearing on the current amendment request.

A delegation of authority was included in the September 13, 2013, letter but it was not signed by your proposed RSO at that time and it included language that it would expire in one year's time.

You may re-use the delegation of authority format in that letter but you, as the proposed RSO, must also sign it and it should not contain language stating that it will expire in a certain time period. Please omit an expiration date or language alluding to that.

ACTION REQUIRED (IF ANY)
