Dear Administrative Judges:

In its Order dated March 5, 2009, the Atomic Safety and Licensing Board (“Board”) directed the NRC staff (“Staff”) to tender each month a status report advising as to whether the estimated dates for issuance of the final Safety Evaluation Report (“SER”) (predicted for the late summer of 2009) and the final environmental review document (predicted for December of 2009) have changed.¹ On July 26, 2013, the Staff informed the Board and the parties of the public availability of the SER. The SER can be accessed electronically via ADAMS Accession Number ML110820512.

The Staff still expects to be able to issue the final environmental review document by the end of December 2014. In keeping with the Board’s mandate, the Staff will tender its next monthly status report by August 15, 2014.
