## Office of Administration (ADM) Items of Interest Week Ending July 11, 2014

### <u>Technical Assistance for the Financial Accounting and Integrated Management Information System (FAIMIS)</u>

On June 27, 2014, a follow-up on U.S. General Service Administration (GSA) Schedule order (GS10F2074P/NRC-HQ-7N-14-T-0001) was awarded to The Mil Corporation of Bowie, MD. This contract will provide technical assistance for FAIMIS. The period of performance is July 1, 2014, through June 30, 2015 for the amount of \$480,267.00, with a 1-year option to extend the term of the contract for the amount of \$489,866.50. The total price for the order is \$970,133.50, inclusive of the option.

#### Federal Information Processing Standards Compliant FM Radio System

On June 30, 2014, a sole source firm-fixed price contract was awarded to Pegasus Radio Corp. (NRC-HQ-40-14-C-0010), a small disadvantaged business. This contract will provide emergency two-way radio communication services. The period of performance is July 1, 2014, through June 30, 2015, with four 1-year option periods. The total contract value is \$265,950.

### Independent Verification and Validation (IV&V) Services for FAIMIS

On June 30, 2014, a task order under an existing NRC Enterprise-Wide Contract was awarded to AEGIS.net Inc., a small business, under (NRC-DR-33-10-324 - NRC-HQ-7N-14-O-0001). The task order provides IV&V services for FAIMIS. The period of performance is July 1, 2014, to June 30, 2016, with a 1-year base period and four 1-year option periods. The total contract value is \$3,909,865.

### Technical Assistance Related to Aging Management of Dry Cask Storage Systems

On July 1, 2014, a cost plus award fee task order was placed with Southwest Research Institute (NRC-HQ-12-C-02-0089 - NRC-HQ-60-14-T-0003) for technical assistance related to aging management of dry cask storage systems. The period of performance is July 1, 2014, through June 30, 2016. The total contract value is \$1,488,406.

### <u>Personnel Security Adjudication Tracking System (PSATS) Development, Modernization, and Enhancement (DME)</u>

On July 1, 2014, a GSA task order (GS06F0826Z - NRC-HQ-40-14-T-0001) was awarded to Array Information Technology, Inc., a Small Business Administration Section 8(a) vendor for DME services associated with PSATS, to include specific system enhancements and integration with NRC Information Technology systems. The period of performance is July 1, 2014, through June 30, 2019, with a 1-year base period and four 1-year option periods. The total contract value is \$940,000.

### <u>Atomic Safety and Licensing Board Panel (ASLBP) Hearing Room Audio Visual (AV)</u> Refresh

On July 7, 2014, as a result of an 8(a) non-competitive solicitation, an indefinite quantity, indefinite delivery time-and-materials contract with a minimum ordering amount of \$2,500.00 and a maximum ordering amount of \$900,000.00 (NRC-HQ-7D-14-C-0002) and its first task order were awarded to Dynamic Systems Integration, Inc., in Virginia Beach, VA. The contract will provide contractor support services to refresh/upgrade the ASLBP hearing room AV capabilities. The period of performance is July 7, 2014, through July 6, 2019, with four 1-year options. The total contract value is \$74,494.77.

## <u>Inflation Adjustments to the Price-Anderson Act Financial Protection Regulations;</u> <u>Corrections: Correcting Amendments; 10 CFR Part 140 (Regulation Identifier Number (RIN) 3150-AJ25; NRC-2013-0072)</u>

On July 9, 2014, the NRC published a correcting amendment in the *Federal Register* (79 FR 38768) correcting a final rule published in the *Federal Register* on July 12, 2013, (78 FR 41835). This correcting amendment makes a necessary conforming change to a concomitant NRC regulation. This rule is effective on July 9, 2014.

### <u>Low-Level Radioactive Waste Regulatory Program: Strategic Assessment Update:</u> Extension of Comment Period; 10 CFR Part 61 (NRC-2014-0080)

On July 9, 2014, the NRC published a document in the *Federal Register* (79 FR 38796) regarding a document published in the *Federal Register* on May 15, 2014 (79 FR 27772), requesting public comment on developments concerning the Low-Level Radioactive Waste Regulatory Program. The public comment period was originally scheduled to close on July 14, 2014. The NRC has decided to extend the public comment period to allow more time for members of the public to develop and submit their comments. The due date for comments requested in the document published on May 15, 2014, is extended to September 15, 2014.

## Export Controls and Physical Security Standards: Final Rule; 10 CFR Part 110 (RIN 3150-AJ33; NRC-2014-0007)

On July 10, 2014, the NRC published a final rule in the *Federal Register* (79 FR 39289) amending its regulations pertaining to the export and import of nuclear materials and equipment. This rulemaking is necessary to conform the export controls of the United States to the international export control guidelines of the Nuclear Suppliers Group, of which the United States is a member, and to incorporate by reference the current version of the International Atomic Energy Agency's document (IAEA), "Nuclear Security Recommendations on Physical Protection of Nuclear Material and Nuclear Facilities (IAEA Information Circulars/225/ Revision 5), January 2011." Also, this final rule makes certain editorial revisions and corrects typographical errors. The final rule is effective August 11, 2014.
