SUBJECT: SUMMARY OF PUBLIC MEETING WITH THE REPRESENTATIVES

OF THE ELECTRIC POWER RESEARCH INSTITUTE

NONDESTRUCTIVE EXAMINATION INTEGRATION COMMITTEE AND PERFORMANCE DEMONSTRATION INITIATIVE PROGRAM

(TAC NUMBER ME8140)

On July 10, 2014, the U.S. Nuclear Regulatory Commission (NRC) staff participated in a public meeting with the Electric Power Research Institute (EPRI) Nondestructive Examination Integration Committee and Performance Demonstration Initiative program (NDEIC/PDI) representatives. The meeting took place at the NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The purpose of the meeting was to provide status of industry actions taken on NDE issues including bolting, site specific mockup, team scanning, and Diablo Canyon operating experience (OE). The meeting participants, agenda, and action items are provided in Enclosures 1, 2, and 3, respectively. Handouts and presentations of the meeting are provided in Enclosure 4.

In December 2013, industry informed the NRC staff about deviations between the PDI bolting program and Supplement 8 of Appendix VIII, Section XI of the American Society of Mechanical Engineers Boiler and Pressure Vessel Code (ASME Code). Industry provided detailed information to the NRC staff during the January 2014 public meeting. Industry determined that the deviations have existed since inception of the PDI bolting program. In the current meeting (July 2014), industry reported that it has taken corrective actions that included development of ASME Code Case N-834 "ASTM A988/A988M-11 UNS S31603, Subsection NB, Class 1 Components Section III, Division 1," issuance of interim guidance, extent of conditions assessment, and updating the PDI Generic Bolting Ultrasonic Testing Examination Procedures. Industry provided details in a presentation entitled "PDI Bolting Program Update."

Industry presented its responses to the NRC staff's comments and concerns regarding the site specific mockups process and the team scanning. Industry stated that it has made essential revisions to the site specific mockup process to assure conformity of the site specific mockup process with the Appendix VIII requirement. Furthermore, industry has taken actions to ensure team scanning is implemented properly and used when there is not any other alternative. Industry noted that the work has been ongoing to determine how to incorporate the NRC staff comments. Industry provided details in a presentation entitled "Review of NRC Comments Related to Site Specific Mockups and Team Scanning."

Industry provided updates on its root cause analysis, corrective actions, and extent of condition evaluation of the Diablo Canyon OE. Industry provided details in a presentation entitled "Update of Industry Actions Related to Diablo Canyon OE." The NRC staff questioned whether the maximum scanning speed allowed could have been a contributing factor in missing the flaws. The NRC staff also expressed concerns regarding the industry's extent of condition evaluation. A new action item was created for industry to include a discussion of the extent of condition evaluation in the January meeting.

Industry provided a status report on the initiative taken to ensure alignment between PDI program implementation and Appendix VIII. An action item was created for industry to inform the NRC staff of new ASME Code actions including actions when a new code case is being drafted.

The next quarterly phone call was scheduled for October 15, 2014.
