Re: Nuclear Materials License No. **21-16656-01, Oakwood Hospital-Southshore**, Notice of Proposed Affiliation of Oakwood Healthcare, Inc. with William Beaumont Hospital and Zieger Health Care Corporation

Dear NRC:

This letter is notice to you that Oakwood Healthcare, Inc. proposes to affiliate with William Beaumont Hospital and Botsford General Hospital (through its parent Zieger Health Care Corporation) (the "Affiliation"). As part of the proposed Affiliation, Oakwood Healthcare, Inc. will convert from a directorship corporation to a membership corporation with Beaumont Health, Inc., a newly created nonprofit corporation, as its parent and sole corporate member. The Affiliation is expected to take effect on or about September 1, 2014.

Pursuant to NUREG -1556, below is the required information:

1. The Affiliation will result in a change of control of Oakwood Healthcare, Inc. There will be no change in the corporate identification number of Oakwood Healthcare, Inc. or any of its subsidiaries that own or operate health care facilities. There will also be no change in any health care facility owned or operated by Oakwood Healthcare, Inc. or its subsidiaries.
2. The Affiliation will not result in any changes in personnel responsible for the Radiation Safety Program, authorized users, or any other persons identified on the license or in the license application as having responsibility for radiation safety or authorized to use licensed material. **Michael Arsenault, D.O., R.S.O** will remain the authorized user (**see attached for full list of authorized user information**).
3. Except for the change in control resulting from the Affiliation, there will be no changes in the organization, location, facilities, equipment or procedures that relate to the licensed program. In addition, there will be no changes in the use, possession, location, or storage of licensed materials as a result of the Affiliation.
4. Quarterly audits reported to the Radiation Safety Committee indicate that all calibrations, leak tests, surveys, and inventories are current and properly documented, and will maintain in this state at the time of Affiliation. The most


recent Radiation Safety Committee meeting was July 10, 2014. The next meeting will be on October 9, 2014.

5. All records concerning the safe and effective decommissioning of the facility will remain in place.
6. The licensed program will continue to comply with any existing constraints, conditions, requirements and commitments.

We would appreciate receiving your consent to the change of control of Oakwood Healthcare, Inc. as soon as possible. Thank you for your assistance with this matter.

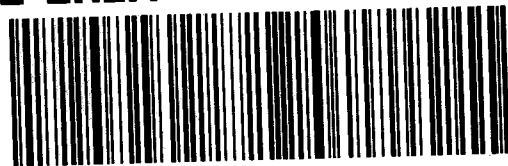
