Discussion: In a letter dated June 4, 2014, the licensee requested that John Lahaniatis, M.D. be added as an AU for 325.600 materials. Dr. Lahaniatis is currently on the license for 35.300 and 35.400 materials. A preceptor form was completed for Dr. Lahaniatis but, it was completed incorrectly. Specifically, the board certificate pathway was used. However, Dr. Lahaniatis was certified prior to the NRC recognizing boards. Therefore, I requested that a new preceptor form be submitted that follows the T&E pathway.
