Dear Administrative Judges:

The Staff herein provides notification of the completion of its document disclosure obligations in this proceeding, notification that the Advanced Safety Evaluation Report (SER) Without Open Items is now complete, and a revised Fermi 3 schedule letter dated July 29, 2014.

Pursuant to the Board's Order dated September 11, 2009, and 10 C.F.R. § 2.336(d), the Staff has filed Hearing File updates for the duration of the contested proceeding on admitted contentions. 10 C.F.R. § 2.336(d) states that the disclosure obligation ceases "when the presiding officer issues a decision resolving the contention" absent other instruction from the presiding officer or the Commission.

The Board issued its Partial Initial Decision on the two admitted contentions on May 23, 2014, and formal disclosure obligations ended on that date. The Staff filed its Hearing File update on June 1, 2014, to include documents produced before that date. The Staff has also filed document disclosure updates on July 1, 2014, and today, as a courtesy to ensure that all chapters and sections of the Advanced SER Without Open Items were declared to the other parties.

The enclosed Hearing File Index includes the final sections of the Advanced SER Without Open Items. The index contains the ADAMS accession number, date, and title of each item so as to make the item readily retrievable from the agency's website, <u>www.nrc.gov</u>, using the ADAMS "Find" function. Additionally, the Staff will add the indexed documents to the folder in the agency's Electronic Hearing Docket ("EHD") associated with this proceeding, entitled "Fermi Hearing File." Also attached, consistent with 10 C.F.R. § 2.336(c), is the Affidavit of Adrian Muñiz.

Because the Board has ruled on the merits of all admitted contentions, the FEIS has been issued, and the Advanced Safety Evaluation Report (SER) Without Open Items is now complete, the Staff is providing notice that, as provided by 10 C.F.R. § 2.336(d), it will discontinue its Hearing File updates. Should any new contentions be admitted, thereby triggering further disclosure obligations, Staff would resume those disclosures.

In addition, the Staff has attached a revised schedule letter dated July 29, 2014, that has been sent to the Applicant. The new projected completion date for the Final SER is January 2015.

Dear Mr. Smith:

By letter dated September 18, 2008, (Agencywide Documents Access and Management System (ADAMS) Accession Number ML082730763), Detroit Edison Company (Detroit Edison) submitted a combined license application (COLA) for Fermi 3. This application was subsequently docketed and the U.S. Nuclear Regulatory Commission (NRC) staff began its review of the application.

By letter dated June 6, 2013, the NRC staff communicated to you the need to delay your review schedule due the impact of budget constraints on the licensing activities associated with combined license and early site permit applications. This schedule reflected a projected completion date of December 2014, for Phase 2, "Advanced Final Safety Evaluation Report without open items". However, as a result of our ability to resolve the remaining technical issues, we completed Phase 2 in July 2014. Therefore, we are providing this update to your review schedule.

The new milestones for the four phases of the COLA safety review are provided in the enclosure to this letter. The completed milestones for the three phases of the environmental review are provided as well for your convenience. In addition, any new and significant changes or additions to the COLA or supporting documentation could impact scheduled completion dates. Furthermore, the final revision to the COLA must be received by September 30, 2014, in order for the staff to be able to issue the Final Safety Evaluation Report in accordance with the enclosed schedule.

¹ On December 21, 2012, the Detroit Edison company sent the NRC a letter indicating that, effective January 1, 2013, the name of the company would be changed to "DTE Electric Company." The legal entity will remain the same (see ML12361A437).
