Mr. Chaisson,

As we discussed, attached is an electronic copy of your order. The order was issued on September 10, 2012.

Also, as we discussed, the 18-month period in the Order has already passed. You told me that you did not realize it had passed and that you had not taken the training required in Section V.B of the order because you could not afford to pay for it. You stated that you currently work for Paramount NDT in Bismarck, North Dakota but that you only interpret film and you do not work with the radiography camera. You told me that Chris Schaan, an owner and RSO, will be training you for about 10 hours on Sundays for the next 4 Sundays to meet the training requirements in 10 CFR 34.43 (reference V.B.2 of the Order). The training program has been approved on his North Dakota license.


You also told me that Laurie McGowen will be in North Dakota in April some time to conduct the RSO training and that you planned to take it.

I told you that you should write a letter to the NRC asking for more time to complete the training requirements and to write the article in Sections V.B and V.C of the Order respectively. I told you that you should address the letter to Mr. Roy Zimmerman, Director of the Office of Enforcement. You can write the letter, scan it in and then email it to me and Rachel and we'll ensure that Mr. Zimmerman receives the letter. I did make it clear that currently you are in violation of the Order and that the letter requesting more time is important.

We'll look forward to receiving your letter.

Hi Mr. Roy I am writing this letter to request an extension on a Order that was giving to me in April of 2012, (IA-12-009).
