**Radiation Protection: Advanced Notice of Proposed Rulemaking; Request for Comments; 10 CFR Part 20, Regulation Identifier Number (RIN) 3150-AJ29; NRC-2009-0279)**

On July 25, 2014, the NRC published an advanced notice of proposed rulemaking in the *Federal Register* ([79 FR 43284](#)) to obtain input from stakeholders on the development of a draft regulatory basis. The draft regulatory basis would support potential changes to NRC's current radiation protection regulations. The goal of this effort is to achieve greater alignment between NRC's radiation protection regulations and the 2007 recommendations of the International Commission on Radiological Protection (ICRP) contained in ICRP Publication 103 (2007). Comments are due by November 24, 2014.

**List of Approved Spent Fuel Storage Casks: Transnuclear, Inc. NUHOMS® HD Cask System, Certificate of Compliance No. 1030, Amendment No. 2: Direct Final Rule; 10 CFR Part 72 (RIN 3150-AJ30; NRC-2013-0269)**

On July 30, 2014, NRC published a direct final rule in the *Federal Register* ([79 FR 44264](#)) amending its spent fuel storage regulations by revising the Transnuclear, Inc. NUHOMS® HD Cask System listing within the "List of Approved Spent Fuel Storage Casks," to include Amendment No. 2, to Certificate of Compliance No. 1030. The companion proposed rule was also published in the *Federal Register* on July 30, 2014 ([79 FR 44318](#)). Unless significant adverse comments are received by September 2, 2014, the final rule will become effective on October 14, 2014.

**Public Meetings for License Renewal Process and Environmental Scoping for Fermi Unit 2**

On July 24, 2014, staff conducted two identical public meetings in Monroe, Michigan, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Fermi 2 license renewal application. Approximately 40-60 members of the public attended the meetings, including a staffer from Michigan Congressman Walberg's office and various state and local officials. During the meetings, staff received about 50 scoping comments. The majority of the commenters spoke in favor of the plant; however, some commenters expressed concerns regarding disposal and storage of nuclear waste. The Fermi 2 public scoping comment period ends on August 29, 2014.
