Mr. Chestnutt, this email is to reiterate our telephone conversation this morning that there will be a change in the Project Manager (PM) for the Prairie Island ISFSI License Renewal Amendment (LRA) in the coming weeks. This week and next, Dr. Pam Longmire is on annual leave. While she is on annual leave, Mr. John Nguyen will serve as PM. When Dr. Longmire returns from annual leave, she will resume PM duties until August 25 at which time she will be on a rotation to the Office of Nuclear Regulatory Research (RES). From this time onward, Mr. Nguyen will assume PM responsibilities for the Prairie Island LRA. With this change over in PMs, please include both Dr. Longmire and Mr. Nguyen on any correspondence from now until August 25.

We also discussed the acceptability of the changes that Xcel Energy made to the aging management program for high burn up fuel. As provided this morning, the technical review organization finds the changes to be acceptable.
