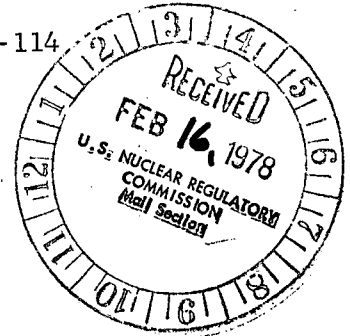

The following are corrections to be made to the H. B. Robinson Steam Electric Plant Effluent and Waste Disposal Semi-Annual Report for the period of January 1, 1977, thru June 30, 1977.

- 1.) On page 5, change the maximum gross gas release rate during any one hour period from 1.43E05uCi to 5.94E06uCi.
- 2.) On page 17, change the total activity of solid waste shipments from 2.93E01 curies to 2.89E01 curies.
- 3.) On page 17, change evaporator bottoms curies from 2.70E01 curies to 2.75E01 curies.
- 4.) On page 17, change Dry Waste curies from 2.32E00 curies to 1.37E00 curies.
