This letter is to inform you of the status of actions regarding Mr. Scott W. Frampton, LCDR(ret), USN, formerly Radiation Safety Officer of Naval Medical Center San Diego. The Navy has completed its investigations of Mr. Frampton's willful violations in his actions surrounding the forgeries of the Commander's approval and signature on Navy Radioactive Material Permit (NRMP) documents. Mr. Frampton has been relieved of all radiation safety duties and is permanently prohibited from any occupational involvement in future NRMP activities.
