Good Afternoon Dr. Mitchell:

I have been assigned to do the technical review on your amendment request received May 19, 2014, to add an AU, to your license.

In one sentence at the beginning of the amendment request, you ask that Dr. John Stamato to be authorized for 10 CFR 35.300 and 10 CFR 35.400 materials as his current authorization under Memorial Hospital of Sheridan County license (49-10982-01).
