### Discussion:

I called to confirm the status of the response to the Request for Additional Information that was sent to the licensee on July 26, 2014. Dr. Vahjen (interim RSO effective August 1, 2014) stated that he is now working on the response since taking over from CPT Cho (the former RSO and contact individual listed for the action), who is no longer with the facility.

I also inquired about the use of I-131 for imaging and localization studies, as this was not indicated in the amendment request and is part of their license authorizations. The amendment request letter indicated that the licensee was planning to transition to a new location of the Martin Army Community Hospital (effective October 1, 2014), and would like to add new locations of use for Nuclear Medicine and Radioactive Waste Storage. Specifically, the request states: "Added areas of licensed materials use at the Martin Army Community Replacement Hospital, where byproduct materials are used in accordance with either 35.100 or 35.200". Dr. Vahjen stated that he is working with management to finalize whether or not they will be proceeding with any I-131 uses in the new location, and might need some additional time to make that decision. I informed Dr. Vahjen to submit a letter (reviewed and signed by a management representative) with the information as discussed there in and that their amendment to add the new facility would be voided. I also informed Dr. Vahjen to re-submit the amendment request to add the replacement facility once the decision has been made with reference to the mail control number 583969.

Dr. Vahjen agreed to submit a letter by COB August 13, 2014.
