1. Table 2.5.4-209 referenced in the proposed language included in the RAI responses has a unit weight for muck/peat = 80; Latest FSAR rev. has unit weight =73
2. Proposed FSAR changes based on response to RAI 2.5.4-1 deletes the commitment on performing microgravity survey at foundation level. Rev 5 of the FSAR has this commitment.
3. FSAR Section 2.5.4.1.2.2 proposed additions based on RAI 2.5.4-25 were not included in the Rev 5 version.
