I met with Michele Sampson, prior to her rotation; with Jennifer Davis while she was Acting BC, and most recently with Tim Lupold and Jennifer Davis to discuss the issue 1 below. I raised Issue 2 with just you and

Jennifer. Although I have raised these issues on several occasions over the last three months or so, I have yet to get any feedback.

I still need to have some feedback and path forward on the following two issues:

1. Decommissioning

The Decommissioning Reactors are submitting licensing actions requests (exemptions, etc) to both their Part 50, as well as, their Part 72 licenses. NSIR is already working with NRR on the Part 50 security related requests. I need to know if NMSS is going to handle the Part 72 requests or whether you want NSIR to do the reviews. The decommissioning reviews are a high priority and time sensitive and some action needs to be taken. As I indicated to NMSS in our discussions, I cannot begin any review unless I get a work request or TAR to start the process.

As a separate issue, you were trying to determine whether or not NMSS were even receiving these requests. If necessary, I can have my staff review the requests from Kewanee, Crystal River, and SONGs that were submitted under both Part 50 and 72 license for action.

2. Prairie Island License Renewal.

NSIR had been involved in review of the current Prairie Island security plan changes, but we have not been involved in the license renewal security plan reviews. You had indicated that an NMSS staff has been assigned to do the security review, which, of course, is NMSS decision. What concerns me though is that there has been no communication between your assigned reviewer and my staff reviewer for Prairie Island or any other NSIR ISFSI staff. I would have expected some communication to just keep abreast of security issues/concerns, orders, past actions, etc. I don't want to have another situation where we find out after the fact there is an issue.

So, I plan on setting up a meeting with you and our respective Division Directors to see if we can't get these issues resolved.
