

**DESCRIPTION OF MODIFICATION:**

1. Section A.3 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), first sentence of paragraph one, shall be deleted in its entirety and replaced with the following:

"This contract shall commence on September 12, 2011 and will expire on September 11, 2015."

2. Section A.4 CONSIDERATION AND OBLIGATION, (c) first sentence shall be deleted in its entirety and replaced with the following:

"(c) The amount presently obligated with respect to this contract is \$1,227,756.80."

3. Section A.9 2052.215-70 KEY PERSONNEL (JAN 1993), paragraph (a), shall be revised as follows:

"(a) The following individuals are considered to be essential to the successful performance of the work hereunder:

- Senior Administrative Support: Zandi Kelley;

- Administrative Support: Geraldine Bennefield
