SUBJECT: SUMMARY OF A PUBLIC TELECONFERENCE ON
AUGUST 28, 2014, WITH MEMBERS OF THE AP1000 DESIGN
CENTER TO DISCUSS AP1000 LICENSING AND TECHNICAL
ISSUES

The U.S. Nuclear Regulatory Commission staff held a Category 2 public teleconference on August 28, 2014, at 2:00 p.m. with members of the AP1000 design center. The purpose of the meeting was to discuss AP1000 combined license (COL) issues. The list of attendees is enclosed. The meeting notice is available in the Agencywide Documents Access and Management System (ADAMS).¹ The meeting notice is also posted on the NRC public website.²

The meeting addressed an August 27, 2014, emailed draft presentation from Duke Energy Florida (DEF), applicant for the Levy Nuclear Plant (LNP) Units 1 and 2 COL, related to a preliminary strategy to assure adequate radiation protection to the main control room (MCR) operators after the direct dose from the MCR emergency ventilation (VES) filter is accounted for in the dose calculations.³ During design finalization, Westinghouse Electric Company (WEC) discovered that direct dose from the MCR VES filter was not accounted for in the AP1000 Design Control Document (DCD), Revision 19. WEC briefed the NRC staff on the issue in a meeting on July 23, 2014. DEF's approach described a departure from the DCD, using site specific MCR atmospheric dispersion factors to offset the dose contribution from the MCR VES filter; other conservative design changes associated with WEC's analysis would be implemented post-COL.

A similar approach will be used for William States Lee III, Units 1 and 2, and Turkey Point, Units 6 and 7, and DEF suggested providing one set of calculations using site specific MCR atmospheric dispersion factors that bounded all three sites and assures adequate radiation protection to MCR operators. The staff noted that this approach would be further considered
