Maintenance Support Renewals for the Office of Nuclear Security and Incident Response (NSIR) Operations Center Systems

On August 28, 2014, as a result of a non-competitive solicitation, Task Order Number NRC-HQ-11-14-T-0004 was issued under contract number NRC-HQ-11-C-07-0015 to Digital Management, Inc. of Bethesda, Maryland. The task order will provide maintenance support services for the NSIR Private Branch Exchange, Voice Recorder, Display System, Iridium Satellite Phones, Web Emergency Operations Center, FaxPress, and the Automatic Notification System equipment located in the NRC Operations Center. The period of performance is August 1, 2014, through November 30, 2015. The total task order price is \$255,807.51.

Revision of Fee Schedules; Fee Recovery for Fiscal Year (FY) 2014; Final Rule; Correction; 10 CFR Parts 170 and 171 (RIN 3150-AJ32; NRC-2013-0276)

On August 29, 2014, the NRC published a document in the *Federal Register* ([79 FR 51470](#)) correcting a final rule that was published in the *Federal Register* on June 30, 2014, ([79 FR 37124](#)), and amended the licensing, inspection, and annual fees charged to the NRC's applicants and licensees. This action is necessary to correct a typographical error in the fee category description in the Schedule of fees for materials licenses and other regulatory services, including inspections, and import and export licenses. The NRC is also correcting a percentage shown for fiscal year 2014 in Table VII, Effort Factors for Fuel Facilities. This correction was effective August 29, 2014.
