**MEETING SUMMARY**

**PURPOSE**

To discuss proposed revisions to the Advisory Committee on the Medical Uses of Isotopes (ACMUI) Bylaws.

**AGENDA TOPIC**

Revisions to the ACMUI Bylaws

**SUMMARY**

The main topics of discussion concerning the bylaw revisions included the use of the word "should" versus "shall," particularly in Sections 1.1.4-1.1.6. The point was made that "should" ensures flexibility if any extreme circumstances arise. "Shall" or "will" implies no flexibility, and that the Committee cannot go forward until the given task is completed. Section 3.1 of the bylaws was also discussed, which describes how to address gaps in positions of the ACMUI. Lastly, Section 1.3.5 concerning the ACMUI's voting and decision-making process, was discussed at length. Questions predominately focused on the wording of Section 1.3.5, as well as how a quorum is to be defined and how voting/decision-making will be carried out.

**RECOMMENDATIONS AND ACTIONS**

The Committee recommended tabling the discussion and vote for changes to the ACMUI Bylaws, particularly regarding the ACMUI's voting and decision-making process (Section 1.3.5). This agenda item will be added to the September 29th ACMUI Meeting, and allotted 15 minutes.
