NOTICE OF HEARING


Notice is hereby given that, by Memorandum and Order (Request for Hearing and Stay of Proceeding), dated October 23, 1997, the Atomic Safety and Licensing Board has granted the request of Magdy Elamir, M.D., Newark, New Jersey, for a hearing in the above-titled proceeding. The hearing concerns the Order Superseding Order Prohibiting Involvement in NRC-Licensed Activities (Effective Immediately) (hereinafter, Superseding Order), issued by the NRC Staff on September 15, 1997 (published at 62 Fed. Reg. 49536 (September 22, 1997)). The parties to the proceeding are Dr. Elamir and the NRC Staff. The issue to be considered at the hearing is whether the Superseding Order should be sustained.


