**Oglala Sioux Tribe’s Hearing Transcript Corrections**

Intervenor Oglala Sioux Tribe (“OST” or “Tribe”) hereby submits these proposed corrections to the transcript for the August 19, 20, and 21, 2014 evidentiary hearing.
