In accordance with the requirements of 10 CFR 95.57(b), Louisiana Energy Services hereby submits a copy of the Monthly Security Event Log (Event Log) for the month of August 2014. Details of each event in the Event Log are available upon request.

Please note a change from the previous Monthly Event Log (July) transmitted last month. Note that the incident titled, "Improper Transport of Classified Matter" (Dated: 05/20/2014 at 1500 hours/Reference Event Report 2014-758) has been removed from the event log. After conducting classification reviews of the components and equipment associated with this incident, it has been determined that there is no evidence of classified data within this equipment according to current classification guidance (CG-LCP-4A). This incident therefore does not meet the reporting requirements of 10 CFR 95.57.

Enclosure 1 contains Security-Related Information and disclosure to the public could present security vulnerability. Accordingly, UUSA requests that Enclosure 1 be withheld from public disclosure in accordance with 10 CFR 2.390(d)(1). The Enclosure 2 affidavit supports this withholding request.
