Discussion: In a letter dated March 4, 2014 and received in RI on 8/29/14, Potomac Valley Hospital (PVH) stated that a change of ownership took place by way of a stock purchase. All of PVH stock was sold to West Virginia University Hospitals, Inc. (WVUH) According to the letter, all personnel, facilities, procedures, etc. remained the same and WVUH confirmed that they would abide by the commitments made by PVH.

In order to complete the Safety Evaluation Report, I contacted Linda Shroyer, Administrator of PVH to obtain additional information concerning the sale of the PVH stock. Specifically, date the sale was completed and evidence of the sale. According to L. Shroyer the sale was completed on March 1, 2014 and she will forward a copy of the stock purchase agreement to RI. In addition, I discussed with L. Shroyer whether or not there had been any change to the management structure since the sale. Ms. Shroyer stated that there have been no changes to the management structure since the sale was completed.
