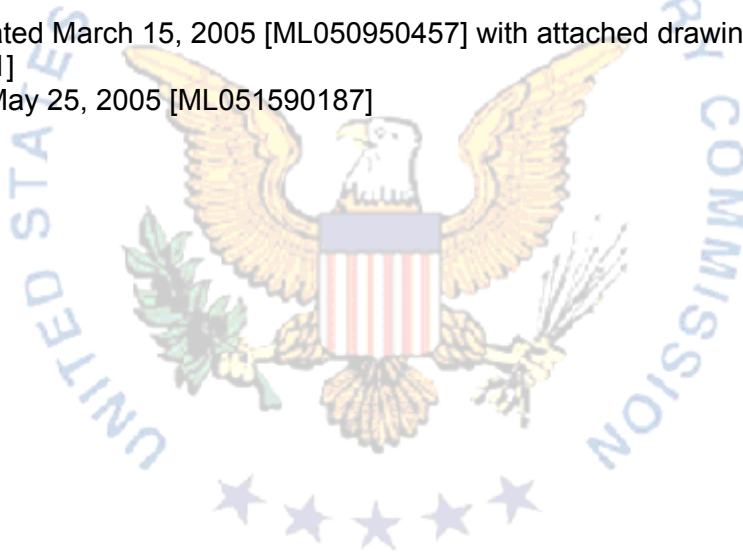
10. A. Licensed material may be used or stored only at the licensee's facilities located at 2213 Ponce By Pass, Ponce, Puerto Rico.
