PURPOSE: This meeting was held at the request of Peninsula Minerals, Ltd. (Peninsula) to present a detailed overview of the proposed Ross *in situ* recovery (ISR) project in the State of Wyoming, and to seek comments on its proposed pre-operational sampling and monitoring program.

BACKGROUND:

Peninsula submitted a Letter of Intent to the U.S. Nuclear Regulatory Commission staff on October 5, 2009. This letter notified the staff that Peninsula intends to submit an application to operate an ISR at the Ross site in Crook County, Wyoming. Peninsula will submit this application in December 2010, and will operate under the name of Strata Energy.

DISCUSSION:

NRC staff read the opening statement for the meeting and Peninsula proceeded to present its slide presentation of the project. Slides presented at this meeting are included as Attachment 1. After the slide presentation, NRC staff reviewed the licensing process with Peninsula and emphasized certain information that might expedite the review process. Particular discussion items included meteorology, geology, hydrogeology, plant and process description, operations, and radiation safety. After NRC staff's discussion, the meeting was opened for questions.
