Ladies and Gentlemen,

Duke Energy submitted the Flood Hazard Reevaluation Report (FHRR) for Oconee Nuclear Station (ONS) on March 12, 2013 (Reference 2) pursuant to the NRC's 10 CFR 50.54(f) request (Reference 1).

By E-mail dated September 15, 2014 (Reference 4), the NRC transmitted a Request for Additional Information (RAI) based on their review of the flood analysis related to Oconee's postulated upstream dam failure. This RAI requests that the dam failure analysis be re-analyzed by applying alternate breach methodologies.

The new analysis will impact the original FHRR as submitted, several RAI (Reference 3) responses that were previously submitted, and impact the schedule for one outstanding RAI (Reference 3) response currently being developed. This letter is providing a schedule for addressing the impacts related to the flood re-analysis, as provided for by the current RAI (Reference 4).

A new dam failure analysis will likely impact several sections of the FHRR, such as; Section 2.3 "Dam Failures" Section 3.3 "Comparison of Dam Failures" Section 4.0 "Interim Evaluations and Actions Taken or Planned", and related appendices.

In addition, several of the responses submitted to the earlier RAI (Reference 3) will be invalidated by a new analysis, those responses are: RAIs 11, 12, 13, 14, and 15.

Finally, even though work on Seismic Analysis of upstream dams in response to RAI 1a and 1b (Reference 3) is nearing completion, the seismic analysis will be an input for rewriting Section 2.3 "Dam Failures."

Based on the impact described above, Duke Energy plans to submit a revision to the FHRR to include the alternate dam failure breach analysis. This revision to the FHRR will also address the questions in RIA's 11, 12, 13, 14, and 15. Also, Duke Energy previously communicated that we would submit responses to RAI 1a and 1b from the previous RAI by November 7, however, the response to RAI 1a and 1b will now also be addressed by the FHRR revision. This plan will allow all the impacts of a new flood analysis to be addresses in one submittal.

Duke Energy expects to submit the FHRR revision by February 15, 2015.

This letter does not create nor revise any Regulatory Commitments.
