Definition of a Utilization Facility

AGENCY: Nuclear Regulatory Commission.

ACTION: Direct final rule; correction.

SUMMARY: The U.S. Nuclear Regulatory Commission (NRC) is correcting a notice that was published in the *Federal Register* (FR) on October 17, 2014, regarding the direct final rule amending the NRC's regulations to add SHINE Medical Technologies, Inc.'s accelerator-driven subcritical operating assemblies, as described in the application assigned docket number 50-608, to the definition of utilization facility. This action is necessary to provide the correct docket identification number and regulation identifier number (RIN) for this action.

DATES: The correction is effective November 5, 2014.
