Economic Simplified Boiling-Water Reactor (ESBWR) Design Certification: Final Rule; 10 Code of Federal Regulations Part 52 (Regulation Identifier Number 3150-AI85; NRC-2010-0135)

On October 15, 2014, the NRC published a document in the *Federal Register* ([79 FR 61944](#)) adopting a new rule certifying the ESBWR standard plant design. This action is necessary, so that applicants or licensees intending to construct and operate an ESBWR design may do so by referencing this design certification rule. The applicant for certification of the ESBWR design is GE-Hitachi Nuclear Energy. This final rule is effective on November 14, 2014.
