SUBJECT: ACCEPTANCE REVIEW OF SOUTH CAROLINA ELECTRIC & GAS COMPANY'S REQUEST FOR LICENSE AMENDMENT AND EXEMPTION (LAR 14-07) FOR THE VIRGIL C. SUMMER NUCLEAR STATION UNITS 2 AND 3: CA04 STRUCTURAL MODULE INSPECTION, TEST, ANALYSIS, AND ACCEPTANCE CRITERIA DIMENSIONS CHANGE (TAC NO. RQ0424)

Dear Mr. Jones:

By letter dated September 25, 2014 (Agencywide Documents Access and Management System (ADAMS) under Accession No. ML14268A388), South Carolina Electric & Gas Company (SCE&G/licensee) submitted a license amendment request (LAR) to Combined License (COL) Numbers NPF-93 and NPF-94, for the Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3, respectively. The proposed license amendment would allow changes to adjust the concrete wall thickness tolerances of four nuclear island walls found in Tier 1.

SCE&G has also requested an exemption from the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, Appendix D, Section III.B, "Design Certification Rule for the AP1000 Design, Scope and Contents," to allow a departure from the elements of the certification information in Tier 1 of the generic design control document.

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of the revised LAR. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical reviews. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.
