SUBJECT: PROFESSIONAL SERVICE INDUSTRIES, INC. - RELAXATION OF

CONFIRMATORY ORDER

Dear Mr. Savage:

By letter dated September 4, 2014, Professional Service Industries, Inc., (PSI) requested that the U.S. Nuclear Regulatory Commission (NRC) rescind the Confirmatory Order (Order) issued to PSI on August 18, 2011, (ADAMS Accession Number ML112291019). The Order currently requires: (1) several one-time actions that were to be performed up to and within 180 days following issuance of the Order, (2) several longer-term actions, which were to be performed up to and within 5 years following issuance of the Order, and (3) payment of a \$15,000 civil penalty. The September 4, 2014, letter was provided following the August 19, 2014, annual report to the NRC regarding compliance with the Order, which noted that PSI had ceased gamma radiography operations.

In the letters referenced above, PSI stated that since the date of the Order, PSI has ceased performing gamma radiography and the license in connection with its prior services has been terminated by PSI. PSI further stated that PSI had ceased to be a radiography licensee on December 19, 2013. Therefore, PSI stated that it would serve no purpose to keep the Order in effect while PSI is not providing services which would be subject to it.

The Confirmatory Order specifies that the Region III Regional Administrator may relax any of the conditions of the Order upon a showing of good cause. My staff, after conferring with the appropriate Agency organizations responsible for oversight of PSI, has reviewed PSI's request, and concluded that there are a number of factors, which, in combination, amount to good cause for relaxing the Order. These included: (1) confirming that PSI completed the one-time actions required by Sections V.1 through V.6 and V.8 through V.12 of the Order, including payment of the civil penalty; (2) confirming that PSI had not performed any work within NRC's jurisdiction since December 19, 2013; and (3) confirming that PSI terminated its Agreement State gamma radiography licenses.

Therefore, after consultation with the Director, Office of Enforcement, I have been authorized to relax the continuing requirements of Sections V.1 through V.7 and V.9 of the Order in their entirety effective this date due to the showing of good cause.

PSI is not required to respond to this letter; however, if it chooses to provide a response, the response should not, to the extent possible, include any personal privacy, proprietary, or safeguards information so that it can be made available to the public without redaction.
