

- 1. We are requesting the address of 600 18th Street, Suite 512, Parkersburg, WV 26101 be added as a second address location on license No. 47-09772-02
- 2. The licensee contact for administrative issues concerning the transfer of license is David K. McClure, CEO, and he may be reached at (304) 424-2131. The contact for technical issues is Daniel A. Berkley, RSO, Camden Clark Radiation Safety Officer (1997).
- 3. There will be no changes in personnel having direct control over licensed activities. Camden Clark's license is being modified accordingly with the above named Cardiologists. The same doctors and staff are still working at this facility.
- 4. There will be no changes in organization, location, facility, equipment or procedures.
- 5. All surveillance items and records are current and will be current at the time of transition.
- 6. We confirm that all records are currently maintained, including those concerning public dose and radioactive spills will be on site for review.
- 7. There will be no records concerning decommissioning and no waste has been disposed of by release to sewer, incineration or in-site burial.
- 8. Routine testing for contamination has shown no contamination on site. Only very short lived isotopes such as Tc-99m and Th-201 are in use at this site. A Cs-137 sealed standard is present for routine quality assurance and is leak tested appropriately.
- 9. There are no open inspection issues at this time.
- 10. Camden Clark agrees to abide by all constraints, conditions, requirements, commitments and representations previously made to the NRC by Parkersburg Cardiology Associates in its existing license.
