ORDER

(Computing Time for Filing a 10 C.F.R. § 2.1213(a) Stay Application)

On November 6, 2014, the NRC Staff notified the Board and parties, pursuant to 10 C.F.R. § 2.1202(a), that it had issued renewed Source Materials License SUA-1534 to Crow Butte Resources, Inc. (CBR).<sup>1</sup> SUA-1534 “allows CBR to possess and use source and byproduct material in connection with its Crow Butte in situ uranium recovery facility in Dawes County, Nebraska.”<sup>2</sup> This notification triggers the five day filing deadline established by 10 C.F.R. § 2.1213 for intervenors to apply for a stay of the license.

The Board notes, considering the importance of a filing of this nature, and consistent with the approach taken by a previous Board, the five day filing timeline will include only

business days.<sup>3</sup> An application for a stay of the effectiveness of SUA-1534 is due by Friday, November 14, 2014.
