SUBJECT: REQUEST FOR INPUT TO FY2014 REPORT ON AGENCY

USE OF STANDARDS

In Circular A-119, "Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities," dated February 19, 1998, the Office of Management and Budget (OMB) requires each Federal agency to submit an annual report on the status of agency interaction with voluntary standards bodies. Circular A-119 further requires each agency to provide in its annual report specific information required by Public Law 104-113, "The National Technology Transfer and Advancement Act of 1995." Among other things, each agency must report the number of agency representatives on standards development committees, provide the number of voluntary consensus standards used during the year, and explain all instances of the agency's use of new "Government-unique standards" (i.e., technical standards developed by the Government for its own use) in lieu of voluntary consensus standards.

Consistent with the requirements of Circular A-119, the Office of Nuclear Regulatory Research (RES) is requesting input from your offices for the NRC's Fiscal Year (FY) 2014 annual report on the agency's development and use of voluntary consensus standards. We would appreciate receiving your inputs no later than November 28, 2014. In addition, we would appreciate your timely cooperation in identifying an office contact person with whom the RES staff can discuss this request as we assemble the information for NIST.
